Facilitating integration of newly arrived immigrants into labour market through adapted vocational / labour market guidance



THE PROJECT

'VET for NAI' project aims to create tools for early and effective integration of newly arrived immigrants (NAIs) into the labour market through integrated training, which targets to enhance the host country language as well as technical skills in their job field.

The project addresses the need to promote integration of NAIs into the labour market through strengthened cooperation and mobilization of employers and social and economic partners in each country. Collaborating partner countries are [Sweden](#), [Greece](#), [Netherlands](#), [Italy](#) and [France](#).

This project will give the NAIs an opportunity for inclusion as well as solve the labour market mismatch problem in EU-countries.

The Guidance Toolkit will be an open resource, available in English, Swedish, Greek, Italian, French.

THE WAY

The project aims to create a Guidance Toolkit, that will provide NAIs with the complementary skills and competences, to enable them to better respond to the requirements of the labour market needs.

The Guidance Toolkit will be based on empowering the NAIs, focusing on active choice on their entrance into the labour market, giving relevant information on the fastest way into the labour market.
